5	We will start with reports from the supervisors.

9	a total of 247 applications for absentee that we received.
10	The breakdown is: 63 regular applications, 55 of those were

13	366, it was slightly elevated.
14	Currently we have military and CVO labels that
15	we're processing now. My people are processing them,
16	waiting for the ballot, of course, to be ready to be mailed
17	out to them.

19	available online at the Department of State's Web site.
20	MADAME CHAIRWOMAN: Which is?
21	MR. SEMINARA: And that Web site is as follows, is

22 www.dos.state.pa.us. And it is under the heading Hot

- 22 MR. DAY: Right now the guys are still conducting
- 23 the PM test on the machines. They should be done that in

- 24 the next two weeks, and I will start laying out all the
 - 1 material for the upcoming election.
 - 2 And the guy is going to come, either late this
 - 3 week or early next week, to service the blotters. So we got
 - 4 that scheduled. Hopefully there is nothing wrong with them.

- 6 MADAME CHAIRWOMAN: Thank you.
- 7 Mr. Lynch.
- 8 MR. LYNCH: Yes. Good morning.
- 9 We actually started this morning proofing the new
- 10 splits.
- Bob Passiore is linking the offices to the new
- 12 precincts as we speak.
- 13 Plus we're also doing -- we're still doing the
- 14 election material boxes and all the other election
- 15 materials, they're being marked up by our temps.
- 16 MADAME CHAIRWOMAN: Okay.
- 17 MR. LYNCH: And, again, if anybody wants to submit
- any watcher requests we'll take them, even though we don't
- 19 have the Watch Books yet, but we can start looking them up,
- 20 so...
- 21 MADAME CHAIRWOMAN: Question about the splits.
- 22 Are those changes in boundaries of precincts, or -- what
- does split mean? Does it mean that you're -- what does
- 24 split mean?

- 1 MR. LYNCH: The new splits from the 2001, that
- one, we reverted back to the 2001 splits that -- precincts.
- 3 So, Bob Passiore had to change them back to what
- 4 they -- he changed them -- remember how they changed?
- 5 MADAME CHAIRWOMAN: Let me tell you my confusion.

6 MR. LYNCH: Sure.

- 7 MADAME CHAIRWOMAN: I know that there was -- in
- 8 the originally proposed 2011 Pennsylvania Senate District
- 9 there was a division that was actually split so that we had
- 10 to petition the Commonwealth Court.
- 11 So -- so, when you say split, that's what I'm
- 12 thinking of, but it sounds like you're talking about
- 13 something different. So could you tell me what you mean by
- 14 a split?
- MR. LYNCH: Yeah. The split is, they're split by
- 16 congressional districts, senatorial, state rep and council.
- 17 But council, obviously, we don't -- we don't -- we
- 18 don't have to worry about this election.
- 19 So, it's in the system, it comes out as a split,
- 20 like, First Senate, First Congressional, First Senatorial,
- 21 State Representative.
- 22 So, we have to check that now that Bob Passiore is
- 23 changing the system back to the 2001 districts. We have a
- $\,$ sheet that we go off, and we're making sure they all match

1 with the ward and divisions.

- 2 MADAME CHAIRWOMAN: So the question is, we're with
- 3 the existing wards and divisions, we're making sure that
- 4 each ward and division -- each division and each ward is --
- 5 MR. LYNCH: Is associated with the right --
- 6 MADAME CHAIRWOMAN: -- associated with the
- 7 correct --

- 8 MR. LYNCH: -- split.
- 9 MADAME CHAIRWOMAN: Thank you. Thank you very
- 10 much.
- MR. LYNCH: Yeah.
- 12 MADAME CHAIRWOMAN: Yes. Anything else?
- MR. LYNCH: And that's it.
- 14 MADAME CHAIRWOMAN: Thank you.
- Mr. Irving.
- MR. IRVING: Good morning, Commissioners.
- 17 The data units, both data imaging, are currently
- 18 up to date on new applications. They're processing
- 19 applications dated from yesterday and today. That includes
- 20 the VMRAs and the electronic applications from the
- 21 Department of Transportation.
- We've also started processing absentee ballot
- 23 requests, okay.
- 24 Everything that we have has been completed and

1 forwarded up to county boards so that they can begin to mail

- 2 out.
- 3 The letter which we send out for people who have
- 4 no party on their application, we received back 113 of those
- 5 so far out of about 500 that we did send back. And we began
- 6 processing -- we've processed those and we put a copy of the
- 7 letter with the party checked off onto each voter's record
- 8 so if anyone were to look that up they would actually see

- where the voter signed and selected a party.
- 10 I've been receiving calls during the week from
- 11 candidates about petition reviews, because the statewide
- 12 candidates filed yesterday, and the legislative candidates,
- 13 they filed today.
- 14 I've discussed this with you prior to this meeting
- 15 about extending our hours, as we have in the past, and we
- 16 would like to have our hours extended so that we begin on
- 17 Saturday morning from 8 a.m. until 4:30 p.m. Saturday and
- 18 Sunday, and on weekdays from 8:30 a.m. until 7:30 p.m, with
- 19 the exception of Fridays. Fridays the norm has been, we're
- 20 out at 5:00. You know people work all week long, they want
- 21 to have a little time to do something. We want to continue
- 22 this up until the 27th, because the 27th is the deadline for
- 23 the last day which the court can fix hearings.
- So, with your permission we'd like to put that

- 1 into affect.
- 2 MADAME CHAIRWOMAN: Any objections?
- 3 COMMISSIONER SCHMIDT: No.
- 4 COMMISSIONER CLARK: No objection.
- 5 MADAME CHAIRWOMAN: No objections.
- 6 MR. IRVING: Okay. I'll have Rich Vito also post
- 7 that on the Web site.
- 8 And that's about it because we're up to date on
- 9 everything, Commissioner.
- 10 COMMISSIONER SCHMIDT: Greg, can you run through

- 13 MR. IRVING: Saturdays and Sundays, yes.
- 14 COMMISSIONER SCHMIDT: And then Monday through
- 15 Friday --
- 16 MR. IRVING: Monday through Thursday 8:30 a.m.
- 17 until 7:30 p.m.
- 18 COMMISSIONER SCHMIDT: And Fridays?
- MR. IRVING: And Fridays we're out at 5:00.
- 20 COMMISSIONER SCHMIDT: 8:30 until 5?
- 21 MR. IRVING: 8:30 until 5.
- 22 COMMISSIONER SCHMIDT: And on Presidents' Day?
- MR. IRVING: Yes. We're going to be opened on
- 24 Presidents' Day. The Commissioner did authorize us to do

- that, also. And on the holiday it will be from 8 a.m.
- 2 until 4:30 p.m.
- 3 COMMISSIONER SCHMIDT: Okay. Saturday and Sunday
- 4 and Presidents' Day.
- 5 MR. IRVING: Right.
- 6 And as we start to dwindle down we'll start to
- 7 scale back on the personnel.
- 8 That concludes what I have for now.
- 9 MADAME CHAIRWOMAN: And is there anyone to give a
- 10 report from Mr. Dowling?
- 11 MR. IRVING: No. I was just informed that Mr.

- 14 date on everything of his campaigns. His part is sitting
- 15 out rejects. They've been out in the mail.
- 16 We haven't been able to mail ID cards, so they're
- 17 mounting up.
- 18 And then we have our machine, which is down. We
- 19 do have -- we have contacted a company about service to that
- 20 unit. And they're supposed to be making contact with me at
- 21 some point in time today.
- They're pretty good. They usually get in here
- 23 right away and get things fixed. And once we get those,
- 24 we'll have those cards sealed so that he can mail those out.

- 1 MADAME CHAIRWOMAN: Thank you.
- 2 MR. IRVING: I'll see to it that he issues all
- 3 three Commissioners a copy of his report when he comes in.
- 4 COMMISSIONER CLARK: Thank you.
- 5 MR. IRVING: You're welcome.
- 6 MADAME CHAIRWOMAN: Next item on the agenda, I'd
- 7 like to ask Deputy Santana to -- to present a proposal on
- 8 the appointment of $\operatorname{\mathsf{--}}$ on the recruitment of machine
- 9 inspectors for vacant divisions. Meaning, divisions where
- 10 the post of machine inspector is vacant.
- 11 DEPUTY COMMISSIONER SANTANA: We're proposing --
- 12 MADAME CHAIRWOMAN: Mr. Santana, stand up. Yeah.
- DEPUTY COMMISSIONER SANTANA: Yeah. We're

- 14 proposing that the City Commissioners recruit and appoint
- 15 machine inspectors for Election Day in polling places where
- 16 there are vacant machine inspector positions as provided
- for in the Pennsylvania Election Code.
- 18 This action could mitigate the potential loss of
- 19 some poll workers when the policy to end double pay is
- 20 enacted, which it has been.
- 21 The City Commissioners and/or Staff will speak
- 22 with affected ward leaders and judges of election to ensure

- 23 that every division has a machine inspector.
- 24 Approval of this proposal affirms Staff can

21 Approvat of this proposal affilms beaff car

- develop a recruitment strategy for this purpose.
- 2 MADAME CHAIRWOMAN: So --
- 3 COMMISSIONER SCHMIDT: Can I ask just one more
- 4 time?
- 5 DEPUTY COMMISSIONER SANTANA: Sure.
- 6 COMMISSIONER SCHMIDT: So, the idea is, that all
- 7 the places where people were double paid, the -- the people
- 8 currently serving in those positions would be contacted by
- 9 --
- 10 DEPUTY COMMISSIONER SANTANA: The issue is, that
- if you look at the vacancies, and the vacancies are --
- 12 there are vacancies in machine inspector already --
- 13 COMMISSIONER SCHMIDT: Right.
- 14 DEPUTY COMMISSIONER SANTANA: -- okay, already,

- 16 potentially -- that could be sited at each site where we
- only have one at times. Often the machine inspector
- 18 position, which is used for that secondary pay line, a lot
- 19 of what we did our research on, who's actually receiving
- 20 double pay, many of those positions are machine inspector
- 21 positions.
- 22 Machine inspectors are one of two positions that
- 23 City Commission actually has some say in terms of being able
- 24 to appoint, if need be, a position to fill the vacancy.

- 1 So, that, therein, lies why we're speaking about
- 2 the machine inspectors.
- 3 COMMISSIONER CLARK: I'd just like to say, we -- I
- 4 mean, that's not anything new. We've always done that in
- 5 terms of, they would call or they would appoint someone,
- 6 the ward leaders and what not, to those.
- 7 I mean, we're in -- we're in compliance in terms
- 8 of --
- 9 DEPUTY COMMISSIONER SANTANA: Sure.
- 10 COMMISSIONER CLARK: -- making sure that we could
- 11 do that.
- 12 DEPUTY COMMISSIONER SANTANA: Sure.
- 13 COMMISSIONER CLARK: But let me also just say,
- 14 that those other positions are elected positions, and you
- 15 have to be very careful because, if you decide to put
- someone in a position of, and I don't want to go to far

- out, clerk or majority inspector, those are elected
- 18 positions, and also different parties that get a Court
- 19 Order and decide that they want someone to sit in a
- 20 position where you might have appointed someone. You can't
- 21 go against the Court, in terms of seating someone from the
- 22 Court, if another party decided to do that.
- 23 If the Republican Party decided to sit a minority
- 24 inspector, then if you have someone there that's a Democrat

- 1 or -- or a Republican, it's not the person they put there
- 2 from the Court, then they could seat that person.
- 3 So, what we want to do is make sure we are in
- 4 compliance with the Court, also.

 $_{\rm HH}$

- 5 And that comes -- that leaves us in a position of
- 6 a case-by-case situation where -- where as though a person
- 7 has been sitting for two hours and then someone comes with a
- 8 Court Order, you have to make a decision -- rather, you're
- 9 going to pay that person or not pay that person.
- 10 That comes back to the situation where you say,
- 11 we're not going to pay double.
- 12 Now, double is, in my point of view, if you are a
- 13 judge of election and you get paid for judge of election
- 14 twice, that's double.
- But if you're a judge of election and there's no
- 16 majority inspector and you decide to do their job, then
- 17 that's a case-by-case situation whether you're going to pay

- 18 them or not.
- 19 Our job is to make sure that the election get
- 20 run -- runs all the way through.
- 21 The situation with the person being majority
- 22 inspector is a situation for us to decide whether we're
- 23 going to pay them or not pay them.
- 24 And then, again, that could be a court issue or
- Ind chen, again, char could be a could lobbe of

- not, depending on, I guess, what we do as well.
- 2 So, I mean, I think that we ought to put that on
- 3 record.
- 4 MADAME CHAIRWOMAN: So, I would, if I may, the --
- 5 Commissioner Clark is absolutely correct, and Deputy
- 6 Commissioner Santana is well aware that the judge, minority
- 7 and majority inspectors are elected, either elected or
- 8 appointed or elected curb-stone election, and that this --
- 9 this proposal has -- says nothing about recruiting for
- 10 those positions. And certainly nothing about appointing,
- 11 because it is not in our power to appoint those positions.
- 12 I also want to remind everyone, that we have
- 13 passed, in a hearing, the policy on no more double pay. So
- 14 that is from the Commission point of view a decision that
- 15 has been made.
- 16 Did you want to say something?
- 17 COMMISSIONER SCHMIDT: Just that the issue with
- 18 the Court -- the Court Orders, because it's dealing
- 19 narrowly with machine inspectors, there would be no Court

- 20 Orders to fill vacant machine inspector positions that
- 21 would put us at odds with it, and there would be for judge
- 22 of elections, majority and minority. But we're not doing
- 23 that for machine inspectors. It's not the case. We won't
- 24 be at odds with the court.

- 1 MADAME CHAIRWOMAN: Mr. Irving.
- 2 MR. IRVING: Yes. In the past it has been the
- 3 norm for -- if someone shows up to the polling place with a
- 4 Court Order, and that person is allowed to work because
- 5 they have an Order from Common Pleas Court saying that they
- 6 are to be seated.
- 7 Now, if they got a Court Order for a position
- 8 that's already occupied, the norm for this department has
- 9 been to find a position on that board for them to work that
- 10 day.
- 11 Now, when you do that, when you sign the spots on
- 12 the payroll sheets, sometimes people are filling out that
- 13 spot which says they're the second machine inspector, when
- 14 in actuality they're not.
- 15 But, see, if your division is only entitled to one
- 16 machine inspector and we see that line has two, it becomes
- 17 an issue of, well, are we crossing this person off when he's
- 18 been there for so long and he's worked it but the other guy
- 19 showed up with a Court Order?
- Those are the things that we have to tweak.

- 21 MADAME CHAIRWOMAN: Yes.
- 22 MR. IRVING: And I hope we can get that resolved
- and get something iron clad before Election Day.
- 24 MADAME CHAIRWOMAN: Um-hum.

- 1 MR. IRVING: I don't like crossing people off, but
- 2 if we have to --
- 3 MADAME CHAIRWOMAN: Right.
- I should clarify that, and Mr. Voigt, please
- 5 correct me if I'm wrong, a division is entitled to only one
- 6 machine inspector if there are no more than two --
- 7 MR. VOIGT: That's correct.
- 8 MADAME CHAIRWOMAN: -- voting machines --
- 9 MR. IRVING: Correct.
- 10 MADAME CHAIRWOMAN: -- at that place.
- 11 So, clarification, if someone has a Court Order to
- 12 be seated, say, as judge of election but they show up at
- 13 10:00 in the morning, do they still have the right to serve,
- 14 or --
- MR. VOIGT: No.
- MR. IRVING: No.
- MR. VOIGT: No.
- 18 MR. IRVING: No. The time I have has always been
- 19 7:30.
- MADAME CHAIRWOMAN: 7:30?
- 21 MR. IRVING: 7:30.
- 22 MADAME CHAIRWOMAN: Okay.

1 adequate.

- 2 MADAME CHAIRWOMAN: Thank you.
- 3 Any other comments or discussions?
- 4 DEPUTY COMMISSIONER SANTANA: If I can say one --
- 5 just one -- one thing?
- 6 MADAME CHAIRWOMAN: Yes.
- 7 DEPUTY COMMISSIONER SANTANA: So, we're actually
- 8 not far from this, from judges of elections, because we
- 9 have been making calls to judges of elections who have had,
- 10 say, issues of double pay or instances where they were just
- 11 missing a check, we have just been engaging them.
- 12 But we're asking them for feedback. And so far
- 13 it's been relatively positive.
- 14 They see this as an opportunity to -- they say,
- let me try; let me try to fill that slot. And if I don't
- 16 I'll give you a call and let you know that I'm having
- 17 trouble filling that slot.
- 18 So, this -- this is going to be a developing
- 19 conversation that we do with the judge of elections with the
- 20 ward leaders to help -- basically, to help them with some
- 21 very challenging situations.
- 22 MADAME CHAIRWOMAN: Thank you.
- 23 Any -- any other discussion?

- 1 response.) MADAME CHAIRWOMAN: So let's take a vote. 2 3 So, the proposal is, that we adopt the memo as read -- the policy as read out by Deputy Santana. 4 Commissioner Schmidt? 5 6 COMMISSIONER SCHMIDT: I make a motion to adopt 7 that policy. 8 MADAME CHAIRWOMAN: Okay. I second the motion. Commissioner Schmidt? 9 10 COMMISSIONER SCHMIDT: I vote in favor. MADAME CHAIRWOMAN: Commissioner Clark? 11 COMMISSIONER CLARK: I vote in favor. 12 13 MADAME CHAIRWOMAN: And I vote in favor. It's unanimous, the vote in favor. 14 15 Thank you very much, Deputy Santana. 16 Next item on the agenda is a proposal from Commissioner Schmidt. 17 18 COMMISSIONER SCHMIDT: It's -- it's really a proposal to -- to consider addressing an issue that I 19 20 became aware of in the last couple of weeks. 21 I met with Amy Kurland, the inspector general, to
- 23 our office and what jurisdiction, if any, they had.
- 24 And they have no -- according to Miss Kurland they

discuss about -- to discuss her office and then to discuss

- 1 have no jurisdiction over the City Commissioners' Office.
- 2 We're an independently elected office. And for all sorts of
- 3 good reasons.
- 4 The -- the issue that I have is, that while we're
- 5 an independent office, we have no internal or external over
- 6 site in terms of conducting administrative investigations or
- 7 criminal investigations or -- or anything like that.
- 8 And that's, at least in my experience working with
- 9 -- with public agencies, a pretty unique situation.
- 10 There's nobody that can -- that can fulfill that
- 11 role. We're big enough to be independent, but we're not big
- 12 enough to have an inspector general or a chief compliance
- 13 officer or a chief integrity officer or anything like that.
- 14 There are a couple of agencies that are also
- 15 independent in Philadelphia city government that have signed
- 16 MOUs with -- with the inspector general's office that would
- 17 consent to the inspector general having jurisdiction to
- 18 conduct investigations.
- 19 They drafted a very broad Memorandum of
- 20 Understanding, and I have some concerns with their draft.
- 21 It's -- so, what I'm asking the other
- 22 Commissioners to consider is, addressing this problem either
- 23 through some form of MOU with the inspector general, or
- 24 addressing it completely independently of the inspector

- 1 general through having someone serve in a -- in a chief
- 2 integrity officer position or something like that.
- 3 But it's -- it's a unique situation, and not a
- 4 good one that we have no internal or external over site to
- 5 conduct investigations.
- 6 So, I'm not moving for a vote or anything today,
- 7 but it is something that I would like us to address.
- 8 MADAME CHAIRWOMAN: Could you share with us your
- 9 concerns about the -- the MOU as drafted?
- 10 I assume that the copy you -- you sent us in
- 11 advance of this meeting, a -- a draft Memorandum of
- 12 Understanding, is that the one that you have objections to,
- 13 or was this drafted to take your objections --
- 14 COMMISSIONER SCHMIDT: No. I have objections to
- it -- or I have concerns about it. I mean, it's very
- 16 broad.
- 17 It basically says, the inspector general has
- 18 complete jurisdiction over this office. And I have some
- 19 concerns about that.
- 20 We can tailor the MOU to be more narrow to say,
- 21 you have jurisdiction to do X, Y and Z independently, or you
- 22 have jurisdiction to do it if it has been notified, the
- 23 Commissioners, before you initiated an investigation.
- There is a whole host of different things that we

- can do to address it. This is the most comprehensive sort
- 2 of umbrella type of jurisdiction.

- I spoke to people in the other agencies that have
- 4 signed MOUs with the inspector general's office, and they
- 5 bought up some -- some good aspects to it, and they brought
- 6 up some -- some concerns about it.
- 7 So, we're just trying to learn from their
- 8 experience what -- what -- what these MOUs have -- have,
- 9 sort of, brought about.
- 10 So, we can really tailor it with them however we
- 11 like.
- 12 MADAME CHAIRWOMAN: Okay. So, can we -- what I
- 13 suggest we do is, that -- I have just a few things that
- 14 concern me that I would like to let you know of, and
- 15 perhaps Commissioner Clark does as well, and then can we
- depend on you to draft an MOU that you think we might be
- 17 able to pass so that we can --
- 18 COMMISSIONER SCHMIDT: Yes. Absolutely.
- 19 MADAME CHAIRWOMAN: -- discuss it at the next
- 20 meeting; terrific.
- 21 So -- so, I had a few questions. First of all, in
- 22 paragraph one it -- the target -- the investigations would
- 23 be of employees, or any employee of a contracted agency, and

- 24 I wonder if that includes poll workers or not, and whether
 - 1 it should include poll workers or not?
- 2 So --
- 3 COMMISSIONER SCHMIDT: Okay.

- 5 like answered.
- 6 COMMISSIONER SCHMIDT: I know it's drafted, but
- 7 what they mean by contracted agency would be a contractor
- 8 that does work with our office.
- 9 But, I mean, that's a good point, if -- if poll
- 10 workers are contracted employees, then --
- 11 MADAME CHAIRWOMAN: And then -- and then, like,
- 12 another point in paragraph two, it gives them quite a lot
- of control to the maximum extent feasible, consistently
- 14 maintaining the integrity of an investigation.
- 15 And I have concern about that phrase, that --
- 16 COMMISSIONER SCHMIDT: I agree.
- 17 MADAME CHAIRWOMAN: -- it's vague.
- I also have concern about item four, which
- 19 mentions the -- that the City Commissioners' Office and OIG
- 20 agree to revisit OIG access to further resource from the
- 21 Commissioners' Office.
- 22 And I also would like to understand more of what
- 23 that means and what we're signing away if we sign that.
- 24 COMMISSIONER SCHMIDT: To visit that issue

1 typically with other MOUs with the IG, we would detail a

- person to the -- to the OIG's office, that they would
- 3 essentially deputize to conduct investigations.
- 4 So, we would pay their salary so that they can
- 5 conduct investigations of -- of our office.

- 6 The original draft of this had that in it. That's
- 7 what they have with the Sheriff's Office, and I think with
- 8 the First Judicial District, and we ask that they take that
- 9 out.
- 10 What that is saying is, that we would agree to --
- 11 to discuss it in the future if it's -- if it's warranted.
- 12 And, also, that either agency can -- can
- 13 end the MOU unilaterally or together.
- 14 MADAME CHAIRWOMAN: Okay.
- 15 COMMISSIONER SCHMIDT: So, this is a draft of,
- 16 really, their most comprehensive approach, you know.
- 17 One of the -- one of the issues, to be -- to be
- 18 frank about it is, the Inspector General's Office is
- 19 independent of the mayor, but it is part of the Executive
- 20 Branch.
- 21 And it has been the Mayor's position that our
- 22 office should not be an elected office, and that it should
- 23 not exist the way that it is currently constituted.
- So, one of my concerns is providing jurisdiction

- 1 to an agency in the Executive Branch for over site of our
- 2 office when the Executive Branch's position is, that we
- 3 should not exist in our current form.
- 4 So, that is probably the biggest concern that I
- 5 have.
- 6 MADAME CHAIRWOMAN: Although the Finance

- Department seems to already be in a position --8 COMMISSIONER SCHMIDT: Yes. That's right. 9 COMMISSIONER CLARK: Absolutely. 10 MADAME CHAIRWOMAN: And where might members of the 11 public see the MOU that we're looking at? 12 COMMISSIONER SCHMIDT: We have -- we have copies if anyone is interested. 13 MADAME CHAIRWOMAN: Thank you. 14 15 COMMISSIONER SCHMIDT: And it is a draft. 16 MADAME CHAIRWOMAN: Any --17 COMMISSIONER CLARK: I mean, they've already --18 this is not anything that is new, they have already been 19 able to investigate us and what not. 20 COMMISSIONER SCHMIDT: They claim that they 21 haven't. 22 COMMISSIONER CLARK: They haven't investigated us? 23 COMMISSIONER SCHMIDT: That they have no -- that 24 they have no ability to move forward with --26 1 MR. VOIGT: The Ethics Commission.
 - 2 COMMISSIONER SCHMIDT: Yes. The Ethics Commission
 - 3 does.
 - 4 COMMISSIONER CLARK: Right.
 - 5 COMMISSIONER SCHMIDT: And has.
 - 6 The inspector general was saying they haven't
 - 7 because they can't because we are independent of them.
 - 8 COMMISSIONER CLARK: Right.

- 10 I want to put a motion on the floor real quick.
- 11 MADAME CHAIRWOMAN: That's not on the agenda, no.
- 12 COMMISSIONER CLARK: I think it is something that
- 13 we all agree with.
- 14 MADAME CHAIRWOMAN: It needs to be on the agenda.
- 15 Thank you.
- Okay. So this --
- 17 COMMISSIONER CLARK: Well, we -- wait. Hold on.
- 18 We don't have to exactly put it on the agenda, we can make
- 19 our own agenda as we go --
- 20 MADAME CHAIRWOMAN: Well, yes.
- 21 COMMISSIONER CLARK: -- as three Commissioners.
- 22 MADAME CHAIRWOMAN: We've made the agenda for this
- 23 meeting, and we have a process for developing the agenda,
- 24 and I will not entertain a motion or a discussion that is

- 1 not on the agenda.
- 2 So, this concludes the --
- 3 COMMISSIONER CLARK: Well, hold on a second.
- 4 MADAME CHAIRWOMAN: -- Commissioners' part of the
- 5 meeting --
- 6 COMMISSIONER CLARK: Hold on a second.
- 7 MADAME CHAIRWOMAN: -- and I'd like to invite the
- 8 public if they have any comments or questions.
- 9 COMMISSIONER CLARK: Hold on a second. I just

- 10 wanted to put a motion on the floor.
- 11 MADAME CHAIRWOMAN: It is not appropriate.
- 12 There's no motion called for on this topic. If you'd like
- 13 to introduce a topic --
- 14 COMMISSIONER CLARK: You don't know what the topic
- 15 is.
- 16 MADAME CHAIRWOMAN: That's right. It's not on --
- 17 because it's not on the agenda.
- 18 COMMISSIONER CLARK: It don't (sic) have to be on
- 19 the agenda.
- 20 MADAME CHAIRWOMAN: Yes. It does. I am the Chair
- 21 and it has to be on the agenda.
- 22 COMMISSIONER SCHMIDT: Let me -- let me just
- 23 clarify for one second.
- The idea behind creating an agenda is, that it
 - 1 would allow the three of us to prepare for the issues that

- 2 we would be voting on, so that things didn't, kind of, come
- 3 up that we would be --
- 4 COMMISSIONER CLARK: Well, let me just say this --
- 5 COMMISSIONER SCHMIDT: -- wasn't prepared to have
- 6 some --
- 7 COMMISSIONER CLARK: The idea of the Sunshine
- 8 Meeting is to speak about some things publicly that you
- 9 want to speak about.
- 10 MADAME CHAIRWOMAN: That is absolutely true, and
- 11 they need --

- 13 hold on.
- 14 MADAME CHAIRWOMAN: -- to be on the agenda.
- 15 COMMISSIONER CLARK: Hold on; hold on; hold on;
- 16 hold on.
- 17 And the Executive Meeting is a meeting where we
- 18 can vote on different things and talk about it the next
- 19 Sunshine Meeting.
- 20 But any Sunshine Meeting you can discuss issues of
- 21 -- if you wanted to make a vote on something.
- MADAME CHAIRWOMAN: That's not true.
- 23 COMMISSIONER CLARK: You can't put together an

24 agenda in secrecy.

1

- 2 COMMISSIONER CLARK: That's clear.
- 3 MADAME CHAIRWOMAN: That's correct.
- 4 COMMISSIONER CLARK: So you can't come and say

MADAME CHAIRWOMAN: That's correct.

- 5 that there is an agenda already.
- Now, we can agree on some things.
- 7 But you can't say -- if you put together an
- 8 agenda, who did you put the agenda with?
- 9 COMMISSIONER SCHMIDT: We -- we all agreed last
- 10 week --
- 11 COMMISSIONER CLARK: No.
- 12 COMMISSIONER SCHMIDT: -- that we would --

- 15 COMMISSIONER SCHMIDT: -- circulate items for the
- 16 agenda.
- 17 COMMISSIONER CLARK: But we didn't put --
- 18 MADAME CHAIRWOMAN: No. That we would circulate
- 19 items for the agenda. And you received a copy.
- 20 COMMISSIONER SCHMIDT: Any item on the list.
- 21 COMMISSIONER CLARK: Okay. But if you listen to
- 22 what I'm saying --
- 23 MADAME CHAIRWOMAN: You received a copy of the
- 24 agenda --

- 1 COMMISSIONER CLARK: But this is what I'm saying,
- 2 we are not bound by an agenda; that's what I'm trying to
- 3 say. That if we wanted to speak about something else we
- 4 could.
- 5 MADAME CHAIRWOMAN: No. Only -- no.
- 6 COMMISSIONER CLARK: Now --
- 7 MADAME CHAIRWOMAN: If two of the Commissioners
- 8 vote -- I suppose that with the -- no.
- 9 COMMISSIONER CLARK: If you --
- 10 MADAME CHAIRWOMAN: No. I'm sorry. No. If it is
- 11 not on the agenda, it is not to be discussed.
- 12 If there are topics you would like to discuss,
- 13 please let my office know by 9 a.m. before the next Sunshine
- 14 Meeting --

- 17 agenda --
- 18 COMMISSIONER CLARK: That's not how --
- 19 MADAME CHAIRWOMAN: -- and we will be glad --
- 20 COMMISSIONER CLARK: -- three Commissioners do it.
- 21 MADAME CHAIRWOMAN: -- to --
- 22 COMMISSIONER CLARK: Now, if you want to speak
- 23 about something and that you just wanted to put a motion on

the floor and you agreed with the motion that we voted,

- that's what I mean, that the vote that we do.
- COMMISSIONER SCHMIDT: I, personally, don't see
- 3 any harm in bringing up issues that are of concern to us,
- 4 but I am not prepared to vote on any motion, so there is no
- 5 point in so making a motion.
- 6 COMMISSIONER CLARK: Okay. Well, I made a motion
- 7 that you are not prepared to vote on a motion.
- 8 Well, what I am basically saying is, that if we
- 9 want to bring up something, as three Commissioners we are
- 10 not bound by an agenda.
- 11 MADAME CHAIRWOMAN: I do not agree, Commissioner
- 12 Clark.
- 13 COMMISSIONER CLARK: Well, that's your opinion,
- 14 it's not a fact.
- 15 MADAME CHAIRWOMAN: That's true. But I am the

- 16 Chair of this Commission, and that gives me -- that gives
- 17 me the undisputed right to run the meeting and to set the
- 18 agenda.
- 19 And I would be delighted to receive from you a
- 20 suggestion on an agenda item and I would put it on the
- 21 agenda. Please send it to my office by 9 a.m. Monday
- 22 morning.
- 23 I would like to proceed to the public comment and
- 24 question part of the meeting.

- 1 Are there any public comments or questions?
- 2 Yes, sir.
- 3 MR. DICKENS: I have a -- I'm fairly new to this
- 4 process. I wanted to know -- my name is Charles Dickens; I
- 5 am committee person in the 16th Ward; 8th Division.
- I wanted to know if there has been any
- 7 consideration or any process whereby we may consider
- 8 actually placing photos of the candidates at the polling
- 9 booths so that it would allow some individuals with
- 10 intellectual disabilities to better identify with the
- 11 candidate?
- 12 Myself being a parent of an individual with
- 13 intellectual disabilities as well as an advocate and social
- 14 worker for intellectual disabilities, I know that a lot of
- 15 times their cognitive deficits don't allow them to be able
- 16 to read things they print, but they can identify with a
- 17 picture.

- 18 Like, if you show them a picture, oh, you know,
- 19 that's such and such.
- 20 So, I just wanted to know if there's something
- 21 being considered or processed to assist them fully of some
- 22 sort which I believe would improve that participation in the
- 23 voting process?
- 24 MADAME CHAIRWOMAN: So, thank you very much for

- 1 the question, and I hope that we will be able to continue
- 2 the discussion of your constituents as you see them and
- 3 their concerns.
- 4 And I hope that you will give your contact
- 5 information to Deputy Santana, who is sitting right in front
- 6 of you, if you would like to continue the conversation.
- 7 This Commission has certainly never considered the
- 8 thing that you suggest of about having photographs of
- 9 candidates in the voting booths. That would be covered by
- 10 State Law. It's not something that we could do ourselves.
- 11 However, you should be aware, that there is a
- 12 provision for assistance for voters who have handicaps. And
- 13 someone in my office would be glad to help you understand
- 14 what that law is and how it works.
- 15 Thank you very much.
- MR. DICKENS: Thank you.
- 17 MADAME CHAIRWOMAN: Any other questions or
- 18 comments from the public?
